We the Executives of Chennai Telephones extend a warm greeting to you sir, on the

eve of the Festive Season and hope that soon you will be appointed to lead our Company as a regular CMD. While acknowledging with thanks your message dated 28th August 2014 with regard to our postings on promotion, we the Executives from Chennai are of the firm hope that your assurances both to individual Senior Executives of Chennai and to the Associations with regard to retention of Seniors and Ladies in Chennai on their promotion to DE-Regular will be honored in true spirit.

While transfer on promotion is unavoidable in the overall interest of BSNL as clearly mentioned in your message, it is a hard fact to digest that despite clear vacancy in our Ch.TD and the willingness of the Head of Circle to accommodate as many Executives to the extent of available vacancy strictly on seniority basis, the un yielding attitude of our personnel section <u>by</u> not taking care of the need of this commercially important metro, requires your immediate intervention.

It is a fact that the constraint of other Circles are to be catered to by suitable redistribution of manpower, it is to be noted that a fast developing metro like Chennai where the expectations of Customers are on a high pitch due to the prevailing competitive scenario cannot be given at par treatment with other Circles as far as meeting the shortage is concerned and we are of the considered opinion that as a seasoned Administrator you will be able to prevail upon our personnel section and order for re-posting of as many Executives as possible on strictly seniority basis taking cognizance of the fact that there are <u>42 DE Regular</u> vacancies existing in Chennai as on date and there are about <u>28 vacancies</u> expected in due course once the DGM (Adhoc) promotion order which may be released shortly.

It is once again re-iterated that the personal family circumstances under which several Senior Executives of Chennai have declined their promotion as early as **July 2010** is no better now and in fact it has even worsened as year's passes by and their **only source of hope is your good office only**. We are of the considered opinion that you will put an end to this impasse and restore mental peace for the aggrieved Executives of Chennai by ordering re-posting of officers back to Chennai strictly on the basis of Seniority to the extent vacancies are available.

Your kind gesture in this regard will be highly appreciated and also will be a morale

booster for the deserving officers of Chennai. We on behalf of the Executives of Chennai assure you Sir that the growth of Chennai Telephones will be further enhanced by way of still improved performance.
